I am directed to invite your kind attention to the above subject and to inform that in response to the requests & observations communicated by shortlisted firms following amendments have been made in issued RFP Document henceforth:

- i. As per Rule- 37 (1) of SPPRA 2010 (amended up to date), the Bid Security may be from 1% to 5% and it cannot be waived off. However, keeping in view the concerns of shortlisted firms, the Bid Security amount has now been reduced to 2% from 5%.
- ii. As per Rule-39 SPPRA 2010 (amended up to date), the Performance Guarantee applies to the procurement of all types i.e. for goods, works & services and it cannot be waived off. The requirement of Performance Guarantee is up to 10% of Bid Cost and in the instant case, it is 5% which is reasonable. Hence, the 5% Performance Guarantee of Bid Cost mentioned in RFP Document Data Sheet Clause No. 24.2 at Page No.21 shall remain the same.
- iii. In sub-clause 13.1 of Datasheet on page No. 20 of RFP Document, the qualification requirement of Financial & Procurement Management Expert has been changed and now shall be read as "MBA (Finance) / CA / B.E. (Civil) registered with PEC and Master in Civil / Project Management / Construction Management".
- iv. The RFP document Data Sheet clause 2.5 clearly mentions the detail of "the facilities and inputs to be provided by the Procuring Agency" that does not include Transportation & accommodation of experts to the site. Therefore, bidders shall include that cost of Transportation & accommodation of experts to the site in their financial bid.
- v. The sub-clause 13.1 of Datasheet on page No. 20 of RFP Document "Proof of salary" shall remain the same as per issued RFP Document
- vi. The "Terms and Conditions of Payment" Clause No. 6.5 Sub Clause (1) of Special Conditions of Contract has been changed as under:

"Payments shall be made upon submission of per scheme wise report as per payment schedule mentioned at Special Conditions of Contract Clause No. 9 "Reporting Requirements".

- vii. A column titled "Payment Schedule" has been added in table given in para-2 "Reporting Requirements" of Clause No. 9 of Special Conditions of Contract mentioned in RFP Document with following payment schedule:
 - 10% after submission of Monitoring Frame Work, Operation Plan and validating Tools report.
 - 30% after submission of First Monitoring Visit Report.
 - 60% after the approval of Final Monitoring Visit Report incorporating feedback
- viii. In RFP Document, Special Conditions of Contract Clause No. 9 "Reporting Requirements" in para-2 table column titled "Description of Services/Deliverable Reports (No of copies)" the number of copies of deliverable reports shall be as under:
 - At Sr#1, Monitoring Frame Work, Operation Plan and validating Tools Report (03 copies).
 - At Sr # 3, First Monitoring Visit Report (03 copies).
 - At Sr #5, Final Monitoring Visit Report after incorporating feedback (05 copies)
 - ix. The other terms and conditions of RFP Document shall remain the same.
