1. Meeting started with the name of Allah Almighty. The Convener of the Procurement Committee welcomed the members of the Committee on 18.09.2023 and opened the discussion on the agenda item. He apprised the forum that tender bids have been invited on Single Stage One Envelope Procedure Rule No. 46 (1) of SPPRA Rules 2010 (Amended up to date) with 2% bid security.

2. Tender Notice No. AD(A&A)/52(MEC)/P&D/2023/03 for "Publication of MEC Annual Report 2022-23" was opened on 18.09.2023 at 11:30 am. Total three (03) Nos of bids were received and forum decided to evaluate them in accordance with evaluation criteria and terms and conditions set forth in the bidding documents. The detail of bidders is as under:

3. The Committee scrutinized the bids against the eligibility/qualification criteria mentioned in bidding documents and found all the three (03) bidders as qualified. Moreover, the sample submitted by the three (03) firms were also found to be closely conforming to BOQ/ specification mentioned in bidding documents. Thus, all 03 bids were found to be responsive to the terms and conditions as set out in the bidding document. Later, all the bids were compared & ranked cost wise and results were as under:





